DATE(S): **THURSDAY, November 2nd** – Hot laps and two separate rounds of two lap qualifying time trials for the World of Outlaws (WoO) Craftsman Sprint Cars, and WoO Craftsman Late Models, and hot laps, Qualifying Laps and qualifying heat races for SDS Big Block Modifieds. First round qualifies cars for Friday and second round qualifies cars for Saturday.
FRIDAY, November 3rd – Full racing program for the WoO Craftsman Sprint Cars (30 lap Feature – \$12,000-to-win), WoO Craftsman Late Models (50 lap Feature – \$12,000-to-win), and SDS Modifieds (40 lap Feature).
SATURDAY, November 4th – Full racing program for the WoO Craftsman Sprint Cars (30 lap Feature – \$12,000-to-win), WoO Craftsman Late Models (50 lap Feature – \$12,000-to-win), and SDS Modifieds (40 lap Feature).
TRACK: The Dirt Track @ Charlotte Motor Speedway, Concord, NC (.400 high-banked red clay oval)
PROMOTERS: Charlotte Motor Speedway, LLC (CMS) and World Racing Group, Inc (WRG)
SANCTION: World of Outlaws Craftsman Sprint Car Series

Their decision is final.

This race program will be run under CMS and World of Outlaws Craftsman Sprint Car Series (WoO) rules, and in signing an Official Entry Application (OEA) or taking part in any of the events described in this OEA, all competitors acknowledge that they have received, read and understand all the rules and regulations associated with the event, and hereby agree to abide by all official CMS and WoO Craftsman Sprint Car Series decisions and regulations. Any deviation of these rules and regulations will result in an immediate disqualification. CMS and WoO Craftsman Sprint Car Series reserve the right to alter show format and revise race procedures in the event of, but not limited to, car count, inclement weather, challenging track conditions and/or other extenuating circumstances. WoO Sprint Car Series will enforce and govern all competition, mechanical, procedural, technical and tire regulations and rules.

1. Minors 17 years of age and younger must submit a Parental Consent, Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement/Minor's Assumption of Risk and Release and Waiver of Liability signed by BOTH of their parents (or legal guardians). No exceptions. Download at: <http://www.charlottemotorspeedway.com/waivers>. Pit area rules are strictly enforced.

Minors age 14 and younger in the pit area will be issued identifying lanyard that must be worn at all times.

2. Promoters reserve the right to refuse any application at any time and to close entry once they deem the number of entrants to be sufficient.
3. All cars will be subject to WoO control from the time they enter the garage and/or pit area until they are officially released after the race.
4. Only tow vehicles will be allowed inside pit area.
5. Personal vehicles will be allowed in the LM/SDS pit area in designated areas. Entry for personal vehicles will close at 4:45 each day. Teams will receive one personal vehicle "Lower Paddock" pass with entry. Any additional passes will be \$25
6. Any camping vehicle, that is not a toter or attached to a race car trailer will require a "Lower Paddock" or "Upper Overflow" Camping permit. Permits are \$100
7. One work area vehicle (ATV/Gator/Mule/RHINO or similar), per entry, may be presented for credential – NO RIDERS – work area vehicles must remain in pit area and may not be used on unrestricted areas of CMS. ***There will be a \$25 charge for all additional work area vehicles.***
8. Driver One-Way Communicator (RE Solo III or similar) is mandatory. Driver radio and AMB scoring transponder rental are available.
9. All prize money will be issued from WoO to designated payee. Checks will not be issued without a verified IRS Form W-9 on file. All entrants are participating on their own behalf and are completely independent of the event organizers. As an independent contractor, entrants are assuming all responsibilities for prize money received including all income and withholding taxes that apply to such winnings. NC State law requires CMS to withhold four percent (4%) of any out-of-state participants' winnings.
10. All Participants must hold a 2017 DIRTcar Sprint Car License
