CAMPGROUND REMINDERS

- **Check-Out: 12:00PM • Check-In: 1:00PM**
- **Late Check-Out Requests** must be arranged by 10:00 AM.
- **Quiet Time: 12:00AM - 7:00 AM.** All sound systems must be maintained at a reasonable level and facing inward toward your camping spot. Speakers and generators must be turned off during Quiet Time. Noise levels determined by CMS to be a nuisance may result in expulsion from the campground.
- **Photo ID** must accompany camping credential and be presented if requested by CMS employees
- **Camping Pass and Car Passes** must be visible at all times and must be affixed to the windshield (during events). All vehicles must be approved at the cabin during Check-In.
- **Personal golf carts, low-speed vehicles, motorized bikes, motorized skateboards, etc.** are prohibited.
- **Vehicle/RV Maintenance** All motorized vehicles and camping units must have a valid state license plate and be in working condition at all times at CMS discretion. Any necessary repairs while on property must be completed in a timely fashion and may not damage the site in any way. All vehicles must be within the confines of the campsite and in the gravel. No vehicles may be parked in any of the grassy areas around the campground. Vehicles also may not be parked in an adjacent site as this may prevent another camper from checking into that site. A fee may apply to any vehicles caught parked in another site. No Commercial Vehicles/ Equipment of any kind are to be parked anywhere on CMS Property.
- **Damages** You will be held responsible for any damages to your campsite during your stay. This includes but is not limited to fences, pedestals, gravel, roadways, road signs, and picnic tables.
- **Towing** All campers must be able to tow their camping unit at any time.
- **Trash** must be placed in a receptacle or trash bag. Trash may be placed at the end of your site fence or in the dumpster located in the center of the campground (See map) A cleaning fee may apply for excessive trash left in and around your site at CMS discretion including cigarette butts, pet waste, etc. Campsites must maintain a tidy appearance and avoid any cluttered or messy appearance at CMS discretion.
- **Long Term Camping** All occupied campsites at Camping World Racing Resort are subject to visual inspection. This campground is not intended for permanent residency. All personal belongings must be properly stored to appear as a transient guest. Any camping unit or campsite that does not meet CMS Visual Standards/ Policies for campsite appearance may be asked to leave. Reservations may be cancelled at any point at CMS discretion due to these guidelines. No online reservations longer than 3 weeks will be allowed. All stays longer than 3 weeks must be made via telephone or in person.
- **Camping Unit Year Requirements** All camping units must be built in 2000 or later. Any camping units that do not meet this requirement will be required to submit a photograph of the camping unit for approval to stay at the Camping World Racing Resort prior to arrival.
- **Fires** are only allowed in an above-ground approved container.
- **Pools** No pools over 2 feet tall. If a pool is put on your site, it MUST be on the gravel and not in the grass. Any pool may be deemed unacceptable at CMS employees' discretion.
- **Outgoing mail** may be placed in the mailbox in front of the Log Cabin. See the office for how to address incoming mail/orders. Incoming mail must be picked up within 48 hours.
- **"UAS" aka drones,** are prohibited on Charlotte Motor Speedway Property.
- **Respect other campers' privacy;** do not walk through other campsites.
- **Excessive drunkenness or irresponsible behavior** will result in expulsion from the campground without refund, and may be subject to prosecution.
- **Firearms, dangerous weapons, or fireworks** are strictly prohibited. Failure to comply will result in expulsion from the campground without refund and subject to prosecution.
- **SEWER ADAPTORS ARE MANDATORY** and required to hook up to our septic system.
- **Vehicle and generator exhaust** must be expelled safely into roadways and not into adjacent campsites.
- **Pets** must be under the control and visual observation of their owner at all times and on a leash when outside of the owner's camping unit unless within the confines of the Pet Stop. Campers must clean up after their pets and properly dispose of the waste. Any pets exhibiting aggressive behavior or excessive noise are not allowed.
- **Pet Pens** are allowed but the pet must still remain under constant supervision at ALL TIMES
- **Unauthorized commerce and marketing** on CMS property is prohibited. Violation of this policy will result in expulsion with no refund.
- **Please be careful!** You are responsible for your own safety. Notify CMS Staff of any natural hazards and dangers around property. Swimming is not permitted in any of the ponds, rivers, or streams located on or near Speedway Property.
- **Camping is an outdoor experience.** We do not give refunds due to discomforts of nature.
- **Unauthorized Utility Connections** Charlotte Motor Speedway prohibits the unauthorized connection of phone, internet or electric services while on Charlotte Motor Speedway property. If unauthorized utility connections are discovered you will be evicted immediately from the property. NO UTILITY PROVIDER HAS ADVANCE PERMISSION TO CONNECT ACCOUNTS ON CMS PROPERTY.
