### Important Information! Please read carefully regarding each of the processes below as some of them may have changed.

Enclosed you will find important information regarding 2023 Annual/Single-Event Credentials ("Credential(s)") for all SMIP-affiliated speedways ("Speedway(s)") as set forth below:

Atlanta Motor Speedway Circuit of the Americas Nashville Superspeedway Texas Motor Speedway Bristol Motor Speedway Dover Motor Speedway New Hampshire Motor Speedway Sonoma Raceway Charlotte Motor Speedway Las Vegas Motor Speedway North Wilkesboro Speedway

Credentials remain the property of SMIP and are a privilege that can be revoked without cause. To apply for the Credential, complete the proper paperwork and submit the appropriate insurance documentation, at which time you will be considered for approval. Please read the following requirements for consideration of a Credential:

Eligibility. Credentials are for Business Use ONLY! A separate contract with SMIP (or an affiliate of SMIP), Speedway Motorsports, Levy Restaurants, or NASCAR is required in order to apply for a Credential. You MUST specify your contract type at the top of the 2023 Credential Request Form ("Form") or your form will be considered incomplete. Teams that do not run a full time NASCAR Cup, XFINITY or Truck Series schedule, are not eligible for Annual Credentials and must request the specific Single Event Credentials. The INSURED listed on the Certificate of Insurance ("COI") should match the legal name of the Company on the Form. All golf carts and/or other mobile equipment operating on Speedway property will require a Credential. SMIP requires the make, model and serial number on the Form for equipment requesting the credentials.

<u>Insurance</u>. You must submit a COI along with your Form. The COI should show evidence of Commercial General Liability with limits at a minimum of \$5 Million Dollars per occurrence. If the equipment is street-legal, including auto liability insurance with limits of \$5 Million Dollars per occurrence.

Cost. The cost of each Credential is \$2,000.00 plus 7% tax or \$225.00 plus state tax for each Single Event Credential. A \$75.00 Late Fee is applied to all orders placed after the listed event deadline. These fees are non-negotiable and due to SMIP upon approval of the Form. Please provide a credit card number on the Credit Card Authorization Form and signature for charge authorization. No Credentials will be issued until payment is made in full. Each team organization running a full-time schedule will receive one (1) complimentary "owners" Annual Credential regardless of the number of teams/owners. Each driver will also be given one (1) complimentary Annual Credential.

Receipt of All Credentials. Credentials are issued and applied to equipment by SMIP at the golf cart compound during your first attended Event Weekend by an SMIP representative at the SMIP Golf Cart Compound. Credentials are non-transferable.

Credentials will NOT be mailed.

Expiration. The Annual Credential will be valid until (1) the expiration of your approved COI on file with SMIP or (2) the end of the 2023 racing season, whichever may come first. If your insurance coverage expires before April 2023, a Single-Event credential will be issued at each event until the renewed COI is received. The Annual Credential will be valid through the last full month prior to the month that your insurance coverage expires in. (For example, if your insurance expires July 5<sup>th</sup>; your Annual Credential will be valid through June 2023.) At that time, it will be your responsibility to supply a new COI in order to obtain a new Annual Credential for the remainder of the 2023 racing season, at no additional charge. Single Event Credentials are valid through the event only.

Please send all completed Forms and COI, by email to <u>golfcarts@smiproperties.com</u> by <u>February 10, 2023</u> to ensure we have your Annual Credential at Las Vegas Motor Speedway during the March NASCAR events. ### SMIP GOLF CART CREDENTIAL TERMS AND CONDITIONS

- 1. AGREEMENT: This document when fully executed by the parties shall constitute a valid and binding agreement and unless terminated earlier in accordance with its provisions herein, shall continue through midnight on the day immediately following the completion of the last Event Weekend as identified in the 2023 Event Weekend section of the Request Form (the "Term"). Company represents and warrants that all information provided in the Request Form is and shall remain true and correct. SMIP may decide to execute this Agreement in its sole and absolute discretion.
- 2. FEES: In consideration of the rights granted by SMIP to Company hereunder, Company agrees to pay SMIP the Credential fees and sales tax in the amount indicated on the Request Form (the "Fees"). All Fees owed to SMIP hereunder are due and payable in full at the time of confirmation of the Credential, unless prior arrangements have been agreed to in writing by SMIP. The Equipment will NOT be registered or a Credential issued until such payment is received. In the event a replacement Credential is needed then, Company must surrender the previously issued Credential to SMIP and will only, at that time, be granted the replacement Credential. In the event a Credential is lost and or stolen, Company is obligated to pay the FULL replacement cost of the Credential to SMIP, and will not be granted a replacement until payment has been received, unless otherwise agreed upon in writing by SMIP. Any Credential requests received after the fifteen (15) day event deadline will be charged an additional seventy-five-dollar (\$75.00) processing fee. ALL CREDENTIAL FEES ARE NON-REFUNDABLE.

#### 3. USE:

- (a) <u>Credential</u>: Credentials are non-transferable and must be permanently affixed to the front right-side cowl or centered between the front wheels, mounted in a standard license plate frame. Company must report to the SMIP Golf Cart Compound (the "**Compound**") located in a designated area of the Speedway on the first day of the first Event Weekend for which a Credential is issued, and the required Credential will be applied by SMIP. Failure to display the Credential will result in impoundment and be subject to additional fees. A Credential does not grant Equipment access to the grandstand, concourse or other secured areas of a Speedway's property. At any and all times during the Term, SMIP and/or the Speedway retains the sole and exclusive right to revoke Equipment or Credential privileges'. A Credential becomes null and void on the last day of the preceding month in which Company's insurance policy expires. Company must submit a new certificate of insurance to receive a replacement Credential.
- (b) <u>Rules and Regulations</u>: Company shall observe and abide by the Credential Rules and Regulations **as** described on page 7 in **Exhibit A** attached hereto and incorporated by reference, and with any additional rules or regulations that hereafter may be adopted and announced by SMIP.Company acknowledges and agrees that each Speedway may have additional rules and regulations and policies and procedures regarding Equipment use and that it is Company's responsibility to ensure that it has obtained and understands all applicable rules and regulations, and policies and procedures (collectively, the "Rules and Regulations"). Company shall ensure that its employees, agents and other authorized users of the Equipment and Credentials issued under this Agreement shall be given a copy of the Rules and Regulations.
- (c) <u>Accidents; Damage or Loss</u>: Should Company or Company's Equipment cause or become involved in an accident of any kind, regardless of the seriousness, the operator of Company's Equipment must stop and contact Speedway security and SMIP representatives, and in such event the operator of the Company's Equipment must remain at the accident scene until Speedway and/or SMIP personnel advise they may leave. Neither SMIP nor any Speedway shall be responsible for damage or loss to Company's Equipment or personal property left in or around the Equipment.
- 4. INSURANCE: Company shall maintain, at its own cost and expense throughout the duration of the Agreement the following policies of insurance, with carriers reasonably acceptable to SMIP (COVERAGE LIMITS MAY BE SATISIFIED THROUGH A COMBINATION OF PRIMARY, UMBRELLA OR EXCESS POLICIES) (I) Commercial General Liability including coverage for Bodily Injury, Property Damage, Personal and Advertising Injury, Products and Completed Operations, Contractual Liability and Mobile Equipment with a minimum limit of \$5,000,000 per occurrence and \$5,000,000 in the aggregate. Each liability policy shall name, add, or include as Additional Insured the following: Speedway GLOBE, LLC, d/b/a SMI Properties; Atlanta Motor Speedway, LLC; Bristol Motor Speedway, LLC; Charlotte Motor Speedway, LLC; Circuit of the Americas LLC; Dover Motorsports, LLC, Dover Motor Speedway, LLC, Nashville Speedway, USA, Inc. d/b/a Nashville Superspeedway, Nevada Speedway, LLC d/b/a Las Vegas Motor Speedway; New Hampshire Motor Speedway Children's Charities and/or its subsidiaries and affiliates and each of their shareholders, members, partners, officers, managers, directors, employees, and agents. All such policies shall contain a waiver of subrogation endorsement waiving all rights of recovery against SMIP, its parent companies, subsidiaries, related and affiliated companies. Upon execution of this

Agreement and at any renewal thereafter, Company shall provide certificates of insurance to SMIP as evidence that policies specified in this section providing the required coverage, conditions, and limits are in full force and effect.

Company represents and warrants to notify SMIP within two (2) days of receipt of cancellation notice should any of the above described polices cancel prior to the expiration date. The fulfillment of the insurance obligations hereunder, however, shall not otherwise relieve Company of any liability assumed by Company hereunder or in any way modify Company's indemnity obligations. The provisions of this section shall survive the expiration or termination of this Agreement.

5. INDEMNIFICATION: COMPANY AGREES TO ASSUME ALL RISKS INHERENT TO THE OPERATION AND USE OF THE EQUIPMENT AT THE SPEEDWAY(S) AND SHALL INDEMNIFY, AND DEFEND, SMIP, THE RESPECTIVE SPEEDWAY(S), SPEEDWAY MOTORSPORTS, LLC, SONIC FINANCIAL CORPORATION, SPEEDWAY CHILDREN'S CHARITIES, THEIR PARENT, SUBSIDIARY AND AFFILIATED COMPANIES, AS WELL AS, EACH OF THEIR RESPECTIVE SHAREHOLDERS, MEMBERS, MANAGERS, PARTNERS, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, SUCCESSORS AND ASSIGNS (INDIVIDUALLY "INDEMNIFIED PARTY" AND COLLECTIVELY "INDEMNIFIED PARTIES") FROM ANY AND ALL CLAIMS, DEMANDS, LOSSES, INJURIES, SUITS, ACTIONS, CAUSES OF ACTION, CHARGES, JUDGEMENTS, COSTS AND EXPENSES (INCLUDING ALL REASONABLE ATTORNEY'S FEES AND COURT COSTS) AND LIABILITY FOR ANY INJURY OR DAMAGE TO ANY PERSON OR PROPERTY (INDIVIDUALLY "CLAIM" AND COLLECTIVELY "CLAIMS") ARISING OUT OF, CONNECTED WITH, OR ANY WAY ASSOCIATED WITH, COMPANY'S OPERATION, USE OR MISUSE OF THE EQUIPMENT OR CREDENTIAL, TO THE EXTENT SUCH CLAIM IS CAUSED IN PART OR IN WHOLE BY THE ACT, NEGLIGENCE, FAULT OR OMISSION OF ANY DUTY WITH RESPECT TO THE SAME BY COMPANY, OR ANY OF ITS EMPLOYEES, AGENTS, CONTRACTORS, INVITEES OR OTHERS AUTHORIZED BY COMPANY TO OPERATE AND OR USE THE EQUIPMENT.

COMPANY RECOGNIZES AND AGREES THAT INCLUDED IN THIS INDEMNIFICATION CLAUSE, BUT NOT BY WAY OF LIMITATION, IS COMPANY'S ASSUMPTION OF ANY AND ALL LIABILITY FOR INJURY, DISABILITY AND DEATH OF WORKMEN AND OTHER PERSONS CAUSED BY THE OPERATION, USE, MISUSE, CONTROL, HANDLING, TRANSPORTION OF EQUIPMENT OR CREDENTIAL BY COMPANY. THE PROVISIONS OF THIS SECTION 5 SHALL SURVIVE THE EXPIRATION OR TERMINATION OF THIS AGREEMENT.

**6. MISCELLANEOUS:** All notices, demands and other communications hereunder shall be in writing and shall be deemed to have been duly given if delivered to, or sent registered or certified mail, return receipt requested, first class postage prepaid to the parties at such addresses indicated in the Registration Form. Either party may change the address or facsimile number to which such communications are to be directed by giving written notice to the other party in the manner provided in this Agreement. Nothing contained herein or done pursuant hereto shall construe a partnership or joint venture between the parties hereto, and neither party shall become bound by a representation, act or omission of the other. This Agreement shall not be assignable, whether by operation of law or otherwise, by any party hereto without the prior written consent of the other party. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective permitted assigns. This Agreement constitutes the entire Agreement among the parties pertaining to the subject matter hereof and supersedes all prior agreements, understandings, negotiations and discussions, whether oral or written of the parties. No amendment, supplement, modification or waiver of this Agreement shall be binding unless executed in writing by the party to be bound thereby. Neither party is relying on any promise, statement or representation other than those expressly written in this Agreement. In the event that any provision, or part thereof, of this Agreement shall be held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions, or parts thereof, shall not in any way be affected or impaired thereby. This Agreement and the rights and obligations of the parties' hereto shall be construed under the laws of the State of North Carolina, without giving effect to the principles of comity or conflicts of laws thereof.

## SMIP GOLF CART RULES AND REGULATIONS

Company acknowledges and agrees to abide by any and all rules and regulations, and policies and procedures of SMIP and the Speedways, including but not limited to the following, during the Term of this Agreement. Failure to do so will result in impoundment or revocation of Credential and/or Equipment privileges.

- 1. All Company representatives will be required to sign a Waiver of Liability at the time of Credential pick-up;
- 2. Only valid-licensed drivers who are eighteen (18) years of age or older and authorized by Company, are allowed to operate Equipment;
- 3. Equipment use is for business purposes only; NO JOYRIDING
- 4. DO NOT use Equipment as a means for product sampling or couponing;
- 5. DO NOT take Equipment off of Speedway property;
- 6. DO NOT park Equipment in unauthorized areas of Speedway property;
